Introduction | *The Annual Report 2015* presents the current activities of the library with a brief update of the financial statement exhibiting the income and expenditure of the library for the year 2015. In line with these, it also presents a briefing on the process and progress in achieving the legal registration of the library, which is a primary requirement for formally initiating the regular operations of the library. While the registration process is still in progress, a change in the proceduralities concerning the establishment of the Executive Committee emerged, which was formally re-worked through a meeting. The new mechanism for the formation of the Executive Committee has been illustrated briefly later in this report followed by an introduction to the new executive committee for the year 2015-2016. Finally, the report presents one of our key contributor's acknowledgement of his friends' efforts in organizing a fund raising campaign in Romania for our library. This very wholehearted effort of our foreign yet so close friends has proved again that MPL is a combined effort of friends.

Vision | To achieve social development through ensuring quality of education for the poorest student population and availability of necessary contextual learning opportunities for the adult population.

Mission | To provide educational and learning opportunities and a socialization space for the comparatively poor students and adults with a view to promote social development.

Objectives | a) To facilitate access to quality educational and learning opportunities for mostly the poor students
b) To provide a learning centre for the adult population of the locality

Bank account of the Library

On 19th February, 2013 the library got its own bank account bearing its official name on it. Since then every transaction of the library has been made through bank and kept record of properly. To open the bank account, the bank required MPL to submit the meeting resolutions highlighting the decision about the establishment of a bank account under the founder's discretion. According to the resolution, the founder operates the account until the founder hands the responsibilities over to the Executive Committee. After the shift, the account must be operated by the joint signatures signed by the President and the Treasurer of the Executive Committee, or in the absence of either the President or the Treasurer, by the Treasurer or President, and Secretary of the Executive Committee. 


Registration of the library

To get the registration, the founder of the library submitted documents to the Shyamnagar Upazila social welfare department of the Government of Bangladesh on 18th February, 2013. The Upazila social welfare department forwarded the documents to the Deputy Director of Satkhira Zilla social welfare department on 18th February, 2013 (Memo no- 41.01.8786.000.00.017.13.149/2013, date-18/02/2013). After few months, the founder received a letter (Memo no- 41.01.8700.000.27.008.12.360, date-27/05/2013) from Satkhira Zilla Social Welfare Department asking some corrections in the submitted papers. On 30th December, 2013 the founder of the library re-submitted the corrected documents to get registration of the library. On 26th October, 2014 the Upazila Social Welfare Department forwarded the documents to the Deputy Director of Satkhira Zilla Social Welfare Department.

About 3 months later, we received Non Objection Certificate (NOC) for the name of the library with some conditions issued by Deputy Director of Satkhira Zilla Social Welfare Department (Memo no. 41.01.7800.000.02.012.03.70 date 03/02/2015). One of the conditions was that the registration of the library may depend on the security certificate issued by the National Security Intelligence (NSI). The NSI office asked us to meet them with papers on 17th March, 2015. They required a little change in the papers. However, following their requirements we re-submitted papers on 04th April of 2015.

In August 2015, about five months later, we came to know from District Social Welfare Department that the NSI reported Masud Parves Library negatively. Therefore, Social Welfare Department is unable to provide registration paper to Masud Parves Library. Later, we contacted divisional NSI office requesting them to re-investigate the library. But the divisional NSI office did not receive our application as they do not deal any individual case. They only receive the application sent by any government office. Therefore, we sent our application to the General Director of NSI on 4th October 2015, requesting him to re-investigate the library. Later, on 22nd November of 2015, we have also submitted an application to the Deputy Director of Satkhira Social Welfare Department through Upazilla Social Welfare officer at Shyamnagar Social Welfare office requesting him to re-investigate our library. On

20th December, 2015 we received another Non Objection Certificate (NOC) for the name of the library with some conditions issued by Deputy Director of Satkhira Zilla Social Welfare Department (Memo no. 41.01.8700.000.27.002.15.742 date 06/12/2015). Now the NSI will investigate our library again. If they report the library positively, then, the social welfare department will no longer have any objection issuing our registration. Till then we have been waiting for the report of NSI. The re-investigation application has been attached below-





New mechanism for formation of the Executive Committee

The previous Executive Committee was formed with the teachers and the students from the nearest high school and primary school, and their tenure was for one year. During the registration process, we were suggested by the NSI officer (Field Officer Mr. Faruk) of Satkhira NSI office that people holding governmental responsibilities and positions should not be involved with non-government or extra-government organizations. It was also emphasized that individuals under 18 can not be an executive committee member of any organization. A further corrective point was made on the ground that the tenure of an Executive Committee must have to be at least for 2 years. Following these normative suggestions up, we called for an emergency meeting held on 3th April, 2015 at Union Parishad Member Mr. Hobibor Rahman's house and we raised and discussed the issue regarding new formation of the Executive Committee and the associated changes in the constitution. Founder Mr. Abu Sayed proposed a new mechanism for the reformation of the Executive Committee the corrected requirements of which emerged as follows through a discussion.

- a. education: not below than SSC (Secondary School Certificate) (must have 10 years of schooling)
- b. age: not below than 30 years
- c. occupation: not involved in permanent job (Ex- Govt. Job)
- d. fitness: not physically and mentally ill, here, physically ill means the aged people those who are not capable enough to walk alone because of age.

The "Nearest person", who full fills the criterion to be a member of the executive committee, closest to the library building, will be invited to be an Executive Committee member. If any body form the nearest location is not willing to be the member of the Executive Committee, then, he/she will be replaced by the next nearest person. Thus 9 persons will be selected for the Executive Committee. The position in the Executive Committee will be elected among the selected 9 persons. The tenure of the committee will be for 2 years.

The present audience and members in the meeting accepted the proposed mechanism for the reformation of the Executive Committee that came from the founder. The new mechanism for formation of the Executive Committee were included in the constitution accordingly.

Executive Committee for 2015-2016 year


Following the mechanism stated in the above section, the new Executive Committee for the year 2015-2016 has been formed as follows.

The committee is to take over the responsibilities from the founder soon in an anticipated general meeting. In an initial meeting held on 17th May of 2012, a consensual decision was reached that the founder will transfer the responsibilities to the Executive Committee soon after the construction work finishes. Once the responsibilities are formally handed over, the Executive Committee will govern the library following the guidelines and procedural instructions stated in the constitution.

Abul Hossain, born on 7th April of 1956, has been elected as the Secretary of the Masud Parves Library. He is working as a manager in a rice mill.



Tasir Uddin Gazi, born on 7th August of 1942, has been elected as the Treasurer of the Masud Parves Library. He has a grocery shop and sells groceries.



G.M. Rafikul Islam, born on 15th November of 1977, has been elected as the Organizing Secretary of the Masud Parves Library. He is a day labour.


and to mobilize community, I sent emails, without success. It was imposible, because people start asking me questions “Why Bangladesh? We have huge problems in
